1. Acceptance of Conditions

These Conditions shall apply in place of and prevail over any terms or conditions (whether or not in conflict or inconsistent with these Conditions) contained or referred to in any documentation submitted by the Participant or in correspondence or elsewhere or implied by trade custom, practice or course of dealing. A variation of these Conditions is only valid if Tembo Talents gives notice to the Participant in writing in any official Event material or correspondence prior to the Event (including via email or other electronic means). The Participant shall be deemed to have accepted these Conditions upon completion of the Entry Form. By accessing and or completing the Entry Form, the Participant is agreeing to Tembo Talents making use of the data provided on the Entry Form for Event Information purposes and other marketing communications organized by Tembo Talents. Tembo Talents agrees that the Event Form email and or postal address data will not be passed on to any third parties.

2. Cancellation by participant

2.1 Cancellation by a registered participant is non-refundable.

3. Booking amendments

3.1 Names/registrants cannot be changed prior to the event commencing. All registrations are final.

4. Personal details

4.1 We require you to register your Personal Data in order to make a booking so we can contact you should there be a problem with your registration. Please ensure you check your details for accuracy so as to enable efficient exchanges of communication if need be.

5. Race Specific Terms & Conditions

5.1 The participant accepts that the event they are entering is competitive in nature.

The participant is fully responsible for their actions whilst attending the event. This includes the event centre and during the race itself. Tembo Talents does not accept responsibility for the actions of the participant nor the consequences of such actions.

5.2 Each participant, upon signing the registration form, agrees that they are physically and mentally capable of skating the distance they have chosen. If, during the event, they decide to change their route and distance, then all consequences of this action are theirs alone.

5.3 Each participant accepts full responsibility for any fees or costs incurred or arising from the need for repatriation.

It is mandatory that all skaters to wear a safety approved skating helmet complying with latest standards. Any skater not wearing a helmet will be disqualified from the event and could be liable for damages if involved in an accident on that basis. The skater must accept this as a condition of entry. Tembo Talents reserves the right to refuse entry to the event to anyone with inappropriate equipment or clothing.

5.4 The participant confirms (by the help of their coaches if need be) that the skates they are using for the race and all of their equipment are of a suitable standard and state of road worthiness.

5.5 The Participant agrees to receive pre and post event communications from Tembo Talents. Emails can be unsubscribed with ease, but doing so prevent all future event updates being sent.

5.6 Tembo Talents reserves the right to shorten or alter the published route at any time. Participants do not have the right to claim a refund if the route is shortened.

5.7 Each participant agrees to assign and grant the right and permission for Tembo Talents to use and publish any photographs/film/video/electronic representations and/or sound recordings of the participant on any tembo Talents' activity. The participant hereby releases Tembo Talents from any and all liability from such use and promotion.

5.8 Tembo Talents reserves the right to cancel any event, due to extreme weather conditions. In such an event, each participant's entry shall be automatically moved to the next scheduled race.

5.9 The Participant must complete the registration

5.10 In consideration for being granted the right to participate, the Participant must pay the Entry Fee set out on the Entry Form.

5.11 The Participant shall not be eligible or entitled to participate in the Event until full payment of the Entry Fee has been received by the Event Organizer. No payment shall be deemed to have been received until the Event Organizer has received cleared funds.

- 5.12 The Event Organizer reserves the right to alter the start time of the Event. In the event of a change of start time the Participants will be notified of the revised start time with as much notice as reasonably practicable. No refund in full or in part shall be made for any change in start time for an Event provided the Event takes place on the specified date of the Event.
- 5.13 The Event Organizer reserves the right to change the date of the Event. In the event of such change of date of the Event, and the Participant is unable to attend on the revised date, he/she has 14 days to inform the Event Organizer in writing from when the change in date is announced to receive a refund of their Entry Fee.
- 5.14 All competitors must bring the mandatory Equipment listed for this event.
- 5.15 No competitor must throw away any Litter, except where bin bags are provided.
- 5.16 Tembo Talents age is as from 31ST December according to the constitution under the Kenya federation of roller skating (KFRS) and the Worlds Skate. Example, If Mary is 7 years old and will be turning 8 years on august, then as of 1st January Mary will be 8 years according to the federation rules hence Mary will race in the 8 years category.
